

DONATED GOODS & THE IRS: A TAXPAYER'S GUIDE

Most people know they're entitled to a tax deduction when donating used items to charities. Deciding how much to deduct is the problem. The IRS guideline is fair market value (the price you, an informed and willing seller, would get if you sold the item to an informed and willing buyer). The IRS requires proof you made the donation and documentation supporting its appraised value. This is the privilege and responsibility of the donor. The following guidelines **suggest** some price ranges for items **in good condition**.
